Please keep me informed of what's happening in your District.


### Family Fun Day- Saturday, June 11th

### Grand Master’s Decision - Dispensations

Attached is a copy of a Grand Master’s “decision” advising that henceforth no dispensation will be granted to a Lodge, except in emergency situations based upon material facts specific to a request, when the requesting Lodge or its affiliated building association has a financial obligation outstanding with Grand Lodge for more than 60 days beyond the date such payment is due and payable.

Also attached is a revised form for Lodges to request dispensations. I am also changing the process for the filing and approval of dispensation requests, which you should share with your Lodge leaders.

Lodges should simultaneously send the request via e-mail to the Grand Secretary, the District Deputy Grand Master and the Grand Master. The request should be submitted as soon as the need is determined, but it is recommended that the request reach Grand Lodge at least two weeks prior to the event. District Deputies are requested to advise the Grand Master within 72 hours of this receipt of the dispensation request whether or not they have any concerns or comments on the request, which will be considered by the Grand Master when processing the request.

Please discuss these changes with your Lodges. Copies of the new form and the decision will be sent to Lodges by the Grand secretary and placed on the Grand Lodge web site.

### Dispensations for Bikes for Books Presentations

Last year, Grand Master Walker made a decision that a dispensation was not required to wear Masonic aprons at Bikes for Books presentations. The Committee on Mason-

ic Jurisprudence indicated its agreement with that decision in its report to Grand Lodge, which report – and the decisions and recommendations contained therein – were accepted by Grand Lodge. Therefore, dispensation requests for this purpose are no longer required. However, Brethren choosing to wear Masonic regalia must also wear a coat and tie.

### Recognition of the Grand Lodges of Georgia and Tennessee

As you know, Grand Lodge had a strong debate on the proper stance to take with regard to continued recognition of the Grand Lodges of Georgia and Tennessee over their inclusion of discriminatory membership criteria. Our Grand Lodge reaffirmed that membership should continue to be based solely upon a man being free-born, of faith, proper age, good report and well recommended, and that the establishment of additional inclusionary or exclusionary criteria was inappropriate.

A copy of the letter sent to the Grand Master of Georgia (a similar letter was sent to the Grand Master of Tennessee) is attached. The Grand Secretary will send a copy this week to all Lodges.

### Lodge and Building Association Insurance

The Grand Lodge master insurance policy will not be with Great American beginning June 1st. The new carrier, Philadelphia Insurance, is offering preferred rates and will cover nearly all buildings, including those within one mile of the ocean – unless the building is literally on the shore.

As previously communicated, the Bangor insurer Sargent, Tyler and West no longer services our coverage. All communications regarding insurance should be with the Auburn Insurance Agency, at jryan@auburnins.com (Jan Ryan) or aryan@auburnins.com (Austin Ryan), or by calling (781) 863-8004, with a copy to the Grand Secretary.

We are planning regional insurance seminars for Lodge and building association leaders this fall.

I’d be interested in hearing your thoughts on having such a program here in Maine, or other ways that we might recognize our Lodges and Brethren for their good works within the Fraternity. We don’t do things for the recognition, but it sure is nice to get a pat on the back occasionally.



## DECISION

Whereas Lodges and affiliated building associations often incur financial obligations associated with the purchase of insurance and other products and services from the Grand Lodge of Maine, and

Whereas Lodges are required to file Annual Returns with Grand Lodge and to pay amounts determined thereon not later than January 31 each year, and

Whereas the timely payment of these financial obligations is an obligation of these bodies and their elected officers, and

Whereas some insurance bills remain unpaid more than eight months after payment was due, and Annual Returns are in arrears for as much as four months, and

Whereas, the granting of dispensations requested by Lodges is at the discretion of the Grand Master, now therefore, it is the decision of this Grand Master that:

No dispensation will be granted, except in emergency situations based upon material facts specific to a request, when the requesting Lodge or its affiliated building association has a financial obligation(s) outstanding with Grand Lodge for more than 60 days beyond the date such payment is due and payable.

Dear Brother Lane,

On March 14, 2016, Grand Master David A. Walker wrote to his Maine Brethren expressing his personal objection to the exclusion of men from Freemasonry based upon their sexual orientation, feeling that barring them runs contrary to our beliefs as Masons. He added that the Grand Lodge of Maine would address the recognition of Grand Jurisdictions that deny eligibility in our fraternity based upon exclusionary criteria beyond those prescribed in our ancient landmarks.

The Grand Lodge of Maine met last week and, after much spirited debate, decided for now to formally but firmly pronounce that Maine Masons deplore the creation of any qualification, or disqualification, for membership other than a man be free-born, of good report and well recommended; and we specifically reject any additional membership tests relating to political views, religious practice, race or sexual preference. Of course, each applicant and member must also be of lawful age and believe in God.

While this was the majority position of Grand Lodge members, there was a strong voice for removing recognition of any jurisdiction that denies membership based upon sexual preference. It was also voted that further action will be considered at the May 2017 Annual Communication.

Masonic leaders promise to live by the laws of the land and the Ancient Landmarks of the Craft; to exercise temperance, justice and brotherly love towards all God's children. I fully agree with my Maine Brethren in saying that to deny good men of faith admission into Freemasonry because of their sexual preference is not in concord with our often professed and rightly admired desire to bring together men of every country, sect or opinion.

I count among my close Masonic friends, Brothers of many faiths and races, and different sexual orientations. Each firmly believes in and earnestly practices the tenets of our profession as Masons, and contributes positively to building a society of men dedicated to the work and word of God, and the improvement of mankind, including themselves.

Amity among Grand Lodges is based upon two underlying principles: sharing common core beliefs and recognizing the sovereignty of each jurisdiction. Nothing would please me more than being able to report to my Maine Brethren next May that our jurisdictions are once again in full amity, and that the Grand Lodge of Georgia no longer has membership qualifications fundamentally different from those of the Grand Lodge of Maine.

May we continue to be in warm fraternal correspondence on the important business of our beloved Craft.
